Century Community Charter School has engaged stakeholders using a number of methods. Our school wide communication platforms ParentSquare and SchoolMint were used to notify parents/guardians of opportunities to provide input on school wide spending plans. Parents could include their messages and feedback directly in these platforms which were then reviewed by teachers and school site staff. Surveys were provided to teachers and staff to provide input on areas where funds should be directed, i.e., high need areas. The CCCS Assistant Principal conducted live virtual parent meetings, soliciting feedback from parents, students, and community members. The CCCS Mental Health team also conducted stakeholder outreach to ensure urgent needs were addressed and long-term strategies are implemented to ensure positive outcomes.

Additionally, the School Site Council, composed of parents and staff, provided input to administrators on areas funds could be directed to address learning losses from mandated at-home learning. The ELAC also provided input as it relates to the unique needs of our English Learner population. The SSC and ELAC meet monthly and provide regular input to administration.

Teachers were asked for input during regular weekly staff meetings, in addition to anonymous surveys, and GroupMe app discussions. Students also receive annual surveys to gauge their satisfaction with the school and to provide suggestions for improvements.

School administrators and educational specialists, including the special education coordinator and support staff, meet regularly during the course of the school year to reflect on the effectiveness of instructional delivery methods for our SPED cohorts, and plan for additional or altered interventions based on observations (qualitative and quantitative). Additionally, CCCS conducted a comprehensive needs assessment that included administrators, classified staff, teachers, and parents to identify areas of opportunity for students and groups of students who were not achieving standard mastery and to identify strategies which will be implemented in the LCAP to address those areas of opportunity.

CCCS evaluated its stakeholder engagement opportunities and determined tribes, children who are incarcerated, homeless youth, foster youth, and migrant youth are neither present nor served by CCCS at this time. However, CCCS maintains both homeless youth and migratory youth policies on its website to ensure educational access in the event these students enroll at CCCS. Paper copies are also maintained at the school site.

#### A description of how the development of the plan was influenced by community input.

The overarching theme of the majority of input from all stakeholder groups was more targeted and structured supplemental in-person instruction. CCCS's in-class instructional aides provide this structured, targeted and personalized in-person instruction to students needing additional academic and social-emotional support to achieve academic goals. Placing these aides in the classroom working alongside teachers will address gaps in learning acquisition in real time, rather than awaiting assessment results or when a student displays adverse behavior. This additional in-class support will also strengthen student and family ties to the school and teaching staff, thereby reducing incidences of chronic absenteeism and learning loss, because when students are performing well academically, they are more motivated to attend school and engage with their learning.

CCCS encourages input throughout the school year from the larger community, regardless of whether a community member's child is directly served by CCCS. CCCS provides open public comment during board meetings and ensures advanced notice of all board meetings to ensure the public can attend if they choose. Furthermore, notices of public hearings (in English and Spanish) are posted to the school website when the board is considering annual plans and related spending. Additionally, CCCS provides volunteer opportunities to community members so they may engage with the school and provide feedback and input in real time.
